In his address at the Annual General Meeting of L E Lundbergföretagens shareholders on April 9, President and Chief Executive Officer Fredrik Lundberg will report that net asset value after deferred tax amounted to SEK 513 per share at April 7, 2025, compared with SEK 555 per share on December 31, 2024.

Fastighets AB L E Lundberg's net asset value, included above, was measured at December 31, 2024, with additions for investments implemented in 2025.
